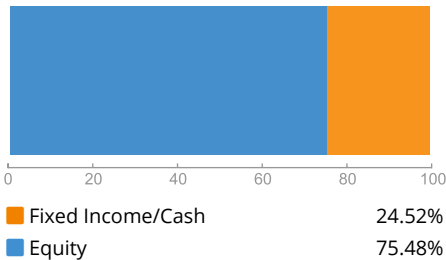

The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life sub-accounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The Astor Sector Allocation Fund, Class A was rated against the following numbers of Tactical Allocation funds over the following time periods: 4-stars out of 231 funds in the last three years, 4-stars out of 211 funds in the last five years and 4-stars out of 141 funds in last 10 years.

29% of the fund's holdings receive an MSCI ESG Rating of AAA or AA (ESG Leaders) and 2% receive an MSCI ESG Rating of B or CCC (ESG Laggards). The fund ranks in the 32nd percentile within the Mixed Asset USD Flex - US peer group and in the 39th percentile within the global universe of approximately 34,000 funds in coverage.
